Each location will choose the winning entry from their location with their own discretion and judgment. Entries will then be mailed to: beekman1802@beekman1802.com to be received by Nov 4, 2011.

3. Beekman 1802 will choose prizewinners based on the recipe and the story behind the recipe. Winners will be announced on December 1, 2011. Three (3) winners will each receive a Beekman 1802 gift basket and each winner and their guests will each receive an author signed copy of the Book and will be flown with a guest to NY for a two (2) night stay in Sharon Springs, NY, and will have the opportunity to tour The Beekman 1802 Farm and have dinner with The Fabulous Beekman Boys at The Beekman 1802 Farm.
